The Township of West Lincoln, being part of Niagara Region is situated on treaty land. This land is steeped in the rich history of the First Nations such as the Hatiwendaronk (Hat-i-wen-DA-ronk), the Haudenosaunee (Hoe-den-no-SHOWnee), and the Anishinaabe (Ah-nish-ih-NAH-bey), including the Mississaugas of the Credit First Nation. There are many First Nations, Métis, and Inuit people from across Turtle Island that live and work in Niagara today. The Township of West Lincoln, as part of the Regional Municipality of Niagara, stands with all Indigenous people, past and present, in promoting the wise stewardship of the lands on which we live.

# 9. REGIONAL COUNCILLOR'S REMARKS

Regional Councillor Witteveen read from a prepared statement which is attached as Schedule "A" to the minutes.

In addition to his prepared statement, Regional Councillor Witteveen shared that he has received a few comments with respect to the speed camera in the community safety area. Regional Councillor Witteveen further explained to Members of Council that should they receive any questions that they can forward them onto him.

The CAO inquired to Regional Councillor Witteveen about the agricultural information provided and if it was the same as the Niagara Agriculture profile. In response to the inquiry from CAO, Bev Hendry, Regional Councillor Witteveen indicated that it was the same information.

Councillor Reilly inquired to Regional Councillor Witteveen about the grace period that had originally been communicated by the region regarding the use of the speed cameras for enforcement. In response to Councillor Reilly's inquiry, Regional Councillor Witteveen explained that he will have to follow up with Councillor Reilly regarding the 90-day grace period that had originally been communicated prior to its initial launch, as he was not sure whether it had actually been adopted or not.

Councillor Reilly further inquired to Regional Councillor Witteveen regarding the remuneration of Early Childhood Educators and how close it was to both the living and minimum wage, despite requiring multiple years of schooling. In response to Councillor Reilly's inquiry, Regional Councillor Witteveen explained that low pay and the discrepancy between ECE pay from the Niagara Region compared to the rest of the industry is driving staffing and retention issues.

Mayor Ganann recognized Regional Councillor Witteveen for bringing up the effectiveness and popularity of the West Lincoln Community Care food bank.
