OVERVIEW:

- In February 2024, Council approved the 2024 Capital Budget that included \$1,280,000.00 for the 2024 Road Rehabilitation project.
- Staff circulated a Tender on March 1, 2024, with two (2) tender submissions received on the closing date of March 21, 2024.
- A low bid in the amount of \$795,767.00 (excluding HST) was received from Walkers Construction Limited.
- Staff recommends awarding the contract to Walkers Construction Limited.
- The total project expenditures are estimated at \$950,000.00, which represents the low bid from Walkers Construction Limited, a project contingency allowance, and net HST.
- Staff recommends that Budget Amendment BA2024-02 be approved, to reflect the project budget reduction of \$330,000.00, with required funding from Development Charges and the Capital Reserve also being reduced.

RECOMMENDATION:

ALIGNMENT TO STRATEGIC PLAN:

BUILD - a safe, connected, caring and active community.

BACKGROUND:

As part of the Township Pavement Management System and the approved 2024 Capital Budget, the following roads were included in the 2024 Road Rehabilitation Program:

- Abingdon Road from North Chippawa to Concession Road 2.
- Concession 3 Rd from Smithville Rd to Caistor Gainsborough Townline Road
- Vaughan Road from Wellandport Rd to Heaslip Road

Please refer to the Schedule A for the locations and key plan for the above roads included in this year's program.

CURRENT SITUATION:

On March 1, 2024, staff circulated a tender document on the Township's Bidding System; Bids & Tenders. On the closing date of March 21 2024, two (2) tenders were received and opened.

Both submissions were checked for completeness, accuracy and arithmetic correctness. All extensions and the totals for all tenders were checked and there were no errors found. The tender bid submissions are as follows:

Company	Tender Price (excl. HST)
Walkers Construction Limited	\$795,767.00
Circle P Paving Inc.	\$877,920.00

The low bidder Walkers Construction Limited and their subcontractors have experience completing similar works in other Niagara municipalities including the Township. The lowest bidder is capable of successfully completing this project.

The costs for each proposed road section were determined, including the tender's general items, provisional items, net HST, and other miscellaneous costs, by prorating to each road's respective budget account. These cost splits are summarized in Schedule B.

Based on this low tender submitted Walkers Construction Limited, the Township's proposed total cost for this project is itemized below:

Total Estimated Cost:	\$ 950,000.00
Project Contingency Non-Recoverable HST	\$ 733,707.00 \$ 137,802.18 <u>\$ 16,430.82</u>
Tender Cost (excluding HST)	\$ 795,767.00

FINANCIAL IMPLICATIONS:

The approved 2024 capital budget amounts for this project are summarized below:

Road Description	Budget
Abingdon Road	\$ 200,000.00
Concession 3 Road	\$ 380,000.00
Vaughan Road	\$ 700,000.00
Total	\$1,280,000.00

The total estimated project cost is within the approved budget of \$1,280,000.00. In addition, the expenditures per the tender are within the allocated budget amounts for each road. Refer to Schedule C for the budgeted funding for this project.

Given that the total project cost of \$950,000.00 is significantly lower than the project budget of \$1,280,000.00, staff are requesting approval of Budget Amendment BA2024-02. This Budget Amendment will reflect a reduction in the project cost of \$330,000.00, along with a reduction in the required funding: \$22,000.00 reduction in Development Charges and \$308,000.00 reduction in the transfer from the Capital Reserve. Details of this can be found on Schedule C.

In the past, when the annual Road Rehabilitation Tender Award was presented to Council, if the project cost was lower than the approved budget, Staff recommended to reallocate the remaining budget funds to complete extra roadworks. However, given the significant pressure that the Township's Capital Reserve is under in years 2025 through to 2027, and in order to ensure the Township remains fiscally responsible and sustainable, this approach is not recommended for the 2024 Road Rehabilitation program.

Instead, Staff is recommending that the Capital Reserve savings of \$308,000.00 are returned to the Capital Reserve, rather than being reallocated. This will have a positive impact on this reserve and the Township, as described further below.

At the February 5, 2024 Special Council Meeting, staff presented the 2024 Draft Operating and Capital Budget (T-03-2024). As noted in the report, the annual reserve transfers includes an amount to pay-back the Capital Reserve over the years 2024 to 2033 related to the 2024 Vaughan Road hard-topping project. This project was funded through internal borrowing from the Capital Reserve, rather than issuing a new debenture. Because of the \$110,000.00 reduction in the Capital Reserve funding needed for this portion, the repayment to the reserve can be reduced. In 2025, this means that there is an anticipated savings of approximately \$21,000.00 due to this lower reserve transfer and thus will reduce the tax levy requirement.

Through report T-03-2024 and during the 2024 budget process, Staff noted that the Capital Reserve is anticipated to be in a very low or negative position in years 2025 through 2027. The above noted savings of \$308,000.00 should help to keep the reserve in a more positive balance, which is critical for sufficient cash flows and to prevent the Township's need to require temporary borrowing and incur borrowing costs.

INTER-DEPARTMENTAL COMMENTS:

This report was reviewed by the Acting Director of Finance, Interim CAO, and the Clerks Department.

CONCLUSION:

In summary, staff recommends that this contract be awarded to the low bidder, Walkers Construction Limited at their bid price of \$795,767.00 (excluding HST), with a total estimated project cost of \$950,000.00.

In addition, Council is asked to approve Budget Amendment (BA2024-02) to reflect a reduction in the capital project costs by \$330,000.00, with reduced funding required from Development Charges and the Capital Reserve.

Staff further recommends that a by-law be adopted authorizing the Mayor and Clerk to enter into an agreement for contract with Walkers Construction Limited for the 2024 Road Rehabilitation construction project as outlined above.



SUBJECT: 2024-2026 Dust Control Tender Authorization

CONTACT: Tray Benish, CRS-S, Manager of Operations Mike DiPaola, P.Eng., Director, Public Works and Recreation

OVERVIEW:

- As part of the Township's annual road maintenance, an application of liquid dust control suppressant (calcium chloride) is used on gravel roads for dust control measures.
- This was developed as a joint Tender with the Township of Wainfleet, to gain cost savings through joint procurement. Additionally, the Tender requested pricing for 3 years to secure long term pricing.
- A Tender document was circulated for the proposed works, which closed on March 18th, 2024. One submission was received from Da-Lee Dust Control.
- Staff recommends the acceptance of the Tender submitted by Da-Lee Dust Control for the 3-year term of 2024-2026, for the supply and application of Calcium Chloride.
- Over the course of the season, staff will be monitoring and reviewing the quantities used in order to stay within the budgeted allocation of \$137,500.00 per year, as approved in the Operating Budget.

RECOMMENDATION:

ALIGNMENT TO STRATEGIC PLAN:

BUILD – a safe, connected, caring and active community

CHAMPION – strategic and responsible growth

BACKGROUND:

As part of regular road maintenance the Township annually applies liquid dust suppressant to gravel roads for dust control measures. The application assists with the reduction of operational costs for regular road maintenance items such as grading. The Township of West Lincoln has approximately 130 lane kilometres of gravel roads requiring annual dust control. Historically, the Township applies approximately 200 to 250 flake tonnes of calcium chloride per year. In order to benefit from 'economics of scale' pricing, the Township has traditionally entered into a joint Tender with the Township of Wainfleet. The Tender closed on March 18th, 2024. In order to secure consistent pricing, a term of three years was tendered.

CURRENT SITUATION:

One (1) Tender submission was received by the Tender closing date of March 18th, 2024. Historically, we have received two (2) Tender submissions for this type of service.

The Tender submission by Da-Lee Dust Control included a per tonne price for a 27,000 litre load as well as a per tonne price for a 16,000 litre load, as per the Tender specifications. The purpose for the smaller load is to apply the dust suppressant on minor dead end roads. The approximate total cost per year will be fall within the annual approved operating budget, which is \$137,500.00 for 2024.

Staff have reviewed the Tender submission from Da-Lee Dust Control and find their pricing for the next 3 years to be acceptable. Da-Lee Dust Control has experience in this application and is capable of successfully completing this project. Da-Lee Dust Control has been the successful bidder for the previous three Tenders and has fulfilled their obligations with no issues.

FINANCIAL IMPLICATIONS:

This program is funded within the approved 2024 Roads Maintenance Operating Budget. There is an annual approved operating budget totaling \$137,500.00 for this maintenance activity. Therefore, over the course of the season, staff will be monitoring and reviewing the quantities used in order to try and stay within the budgeted allocation as approved in the Operating Budget.

INTER-DEPARTMENTAL COMMENTS:

This report has been reviewed by the CAO, the Director of Finance, and the Clerk's office.

CONCLUSION:

In summary, Staff recommends that the bid submission from Da-Lee Dust Control for the application of dust suppressant for gravel road dust control be accepted for the three (3) year term of 2024 – 2026, and that a By-Law be passed to authorize the Mayor and Clerk to enter into an agreement with Da-Lee Dust Control.

OVERVIEW:

- The purpose of this report is to update Council about the details of the "Music, Market and Park It" event series, including survey outcomes and next steps.
- Staff will implement pro-rated fees from the Consolidated User Fees and Charges By-law related to market vendors for the 2024 year.

RECOMMENDATION:

1. That report REC-01-2024 titled "Music, Market and Park It Update", dated April 15, 2024, be received for information.

ALIGNMENT TO STRATEGIC PLAN:

ENRICH - our Strong Agricultural Legacy

BUILD – a Safe, Connected, Caring and Active Community

BACKGROUND:

A new, intensified event series was approved by Council for the 2024 season, marrying the West Lincoln Farmers' Market with Music in the Park and adding a car show. This new event has been named **Music, Market and Park It**.

Council asked for staff to report back after surveying potential vendors for participation in the 2024 Music, Market and Park It events. The main purpose of consulting potential vendors was to choose a day of the week for the events to be held.

A plan was developed in coordination with the Communication Specialist to connect with

potential vendors. This plan included publishing a media release (refer to Schedule A), contacting previous vendors, posting on social media and updating the Township website with details about the new format.

The survey was open to potential vendors from March 18 to March 28, 2024, and included seven focused questions about the upcoming Music, Market and Park It events.

Staff also recognized that the fees related to the Farmers' Market, as set out in the Consolidated User Fees and Charges By-law, may need to be reviewed as a result of the new event format.

CURRENT SITUATION:

Staff has reviewed the results of the survey. Approximately sixty (60) emails were sent to potential vendors to invite them to participate in the survey. Twenty-four (24) responses were received.

Survey Responses:

Question 1

Are you a current or new member for the Farmers' Market in West Lincoln?

- 13 current vendors (54%)
- 11 new vendors (46%)

Question 2

The Farmers' Market was held on Fridays during the 2021 and 2022 seasons. The Farmers' Market moved to Tuesdays during the 2023 season. In your opinion, what day of the week would be best for the new Music, Market and Park It event? (please rank the following options, 1 being your first choice and 5 being your last)

First Choice Results

- Monday: 3 vendors first choice (12%)
- Tuesday: 9 vendors first choice (38%)
- Wednesday: 5 vendors first choice (21%)
- Thursday: 5 vendors first choice (21%)
- Friday: 2 vendors first choice (8%)

Question 3

Would you be interested in participating in the Market held at the Township's Canada Day event?

- 15 vendors said YES (63%)
- 9 vendors said NO (37%)

Question 4

If offered, would you be interested in participating in an additional Spring Market in May?

- 19 vendors said YES (79%)
- 5 vendors said NO (21%)

Question 5

If an additional Spring Market is held in May, would you be interested in taking on a volunteer leadership role to help run this event?

- 5 vendors said YES (21%)
- 19 vendors said NO (79%)

Question 6

If offered, would you be interested in participating in an additional Holiday Market in November?

- 22 vendors said YES (92%)
- 2 vendors said NO (8%)

Question 7

If an additional Holiday Market is held in November, would you be interested in taking on a volunteer leadership role to help run this event?

- 6 vendors said YES (25%)
- 18 vendors said NO (75%)

The survey concluded with an open-ended question to collect additional feedback and suggestions, for staff consideration.

Staff Conclusions Based on Survey Results:

After reviewing the results of the survey, staff will plan to move forward with the six Music, Market and Park It events being held on Tuesdays during the months of July and August. Staff will also plan to include Canada Day as a market opportunity for seasonal vendors as well as a Holiday Market in November, leveraging volunteer resources as needed, since some vendors have expressed interest in a volunteer leadership role. Due to timing, staff will not plan for a Spring Market in May, however consideration will be given to include this event in 2025.

Staff are now moving forward with the next step in the communication plan, which will be to meet with potential vendors to provide final details about the 2024 season, including dates, fees and the application form. The process of hiring an Event Planner, as approved in the 2024 Budget, is also underway.

Market Fees

The Farmers' Market vendors' fees are set through the Consolidated User Fees and Charges By-law each year, as approved by Council. The 2024 fees were set prior to the Music, Market and Park It event details being finalized. Staff has recognized that the market fees need to be adjusted to be fair and appropriate for a shorter market season. As per staff's review, it is recommended that the 2024 market vendor fees be pro-rated for the 2024 market season. In 2023 seasonal market vendors had the opportunity to participate in 22 markets. In 2024, there will be 8 market opportunities. The full season vendor's fees for 2024 will be pro-rated based on this, accordingly. The Farmers' Markets Ontario membership and insurance are annual fees that are not affected by the number of events per season.

The pro-rated fees are summarized in the table below.

*Note – Full Season Vendor fee will be applied for more than 2 weeks of participation

The fee for "Temporary Vendor (per week) limited to 4 weeks" is \$55. This fee cannot be pro-rated as it represents a fee charged per week of participation. Therefore, there will be no change, however, it will be limited to 2 weeks as opposed to 4 weeks. If a temporary vendor participates for 3 or more weeks, then the Full Season Vendor (pro-rated) rate will be applied as it is cheaper of the two.

The Half Season Vendor pro-rated fee will not be applicable in 2024, given that the fees are already being pro-rated to reflect the reduced market season.

Since it is recommended that the fees be pro-rated, and not being changed by an increase or decrease factor, there is no need to amend the Consolidated User Fees and Charges By-law. The pro-rating of fees is an administrative staff action that still complies with the set fees of the Bylaw; therefore, no change to the By-law is required.

FINANCIAL IMPLICATIONS:

There may be a small financial impact on the budgeted revenue for market vendor fees collected in 2024. This is a result of pro-rating the fees to reflect the shorter market season. However, this may be offset by a small reduction in some expenses due to the shortened season. Overall, the net revenue and expense impact is expected to be minimal.

INTER-DEPARTMENTAL COMMENTS:

This Report was reviewed by the Township Interim CAO, the Acting Director of Finance and the Clerk's Department.

CONCLUSION:

After thorough consideration, including input from vendors, the Township of West Lincoln will run the Music, Market and Park It event series on six Tuesdays in July and August.

Seasonal vendors will also be invited to participate in the two additional market opportunities, being Canada Day and Holiday Market.

Staff will implement pro-rated fees in the Consolidated User Fees and Charges By-law related to market vendors for 2024.

- The current cemetery maintenance contractor has notified the Township in March of 2024 that they will no longer be performing the maintenance for the cemeteries.
- Staff prepared and circulated a Request for Proposal for maintenance of the twenty-one cemeteries under the Township's jurisdiction for a five-year term (2024 to 2028).
- Seventeen (17) submissions were received for this Request for Proposal.
- In an effort to award this multi-year maintenance contract based on best value for money, all proposals received were evaluated using a set criterion of 50% (Technical) and 50% (Cost).
- Kelly Dig's Landscaping received the highest score.
- Staff recommends awarding the five-year cemetery maintenance contract to Kelly Dig's Landscaping for a total amount of \$ 123,139.25 (excluding HST) as itemized below on an annual basis:
 - 2024 \$ 23,900.00
 - o 2025 \$ 24,258.50
 - o 2026 \$ 24,622.40
 - o 2027 \$ 24,991.75
 - 2028 \$ 25,366.60

RECOMMENDATION:

ALIGNMENT TO STRATEGIC PLAN:

ADVANCE - Organizational Capacity and Effectiveness

BACKGROUND:

The current cemetery maintenance contractor has notified the Township in March of 2024 that they will no longer be performing the maintenance for the cemeteries. They were retained to complete these services in 2021 and were to continue until 2025. As a result of these developments, staff issued a Request for Proposal (RFP) to solicit competitive submissions for a new five-year cemetery maintenance contract. The contract is for grass cutting, general property maintenance, and landscape repairs for the Township's twenty-one cemeteries.

CURRENT SITUATION:

Staff prepared and circulated the RFP with a closing date of April 9, 2024. The RFP was advertised and posted on the Township's electronic bidding website, Bids & Tenders. Seventeen (17) proposals were received on the RFP closing date.

In an effort to award this multi-year maintenance contract based on best value for money, all proposals received were evaluated using the following set of criteria (50% Technical & 50% Cost) as itemized below:

- Fechnical Expertise & Resources
- Similar Project Experience
- Past Performance Records
- Recognized Cemetery Training
- Methodology
- Local Expertise
- Cost

Out of the seventeen (17) submissions, it was determined that the prices received from nine (9) of the submission were more than double the lowest bid received. As such, those 9 submissions were not evaluated further.

The results of the remaining eight (8) submission that were evaluated are summarized in the below table:

Kelly Dig's Landscaping received the highest overall score. They have the required experience, expertise, and resources to successfully delivery and complete the services set out in the maintenance contract. This company has also completed similar types of work with other local area municipalities and staff have contacted references to confirm their ability to deliver on these services.

The yearly pricing submitted by Kelly Dig's Landscaping are as follows:

2024 \$ 23,900.00
2025 \$ 24,258.50
2026 \$ 24,622.40
2027 \$ 24,991.75
2028 \$ 25,366.60

The above annual pricing is lower than the previous Contractor that was retained in 2021.

FINANCIAL IMPLICATIONS:

The project is to be funded through the yearly cemetery operating budget. The approved 2024 operating budget includes sufficient funds to cover the first year of this five-year maintenance contract. Staff will budget appropriately for the remaining four contract years when developing the annual operating budget.

INTER-DEPARTMENTAL COMMENTS:

This report was reviewed by the Acting Director of Finance and the Interim Chief Administrative Officer.

CONCLUSION:

In summary, staff recommends that the submission from Kelly Dig's Landscaping for the cemetery maintenance contract (2024 to 2028) be accepted, and that Council awards the five-year maintenance contract for a total amount of \$123,139.25 (plus HST).






Number of Drop-In Programs Offered

Participation Levels

Including all of the demographic groups, participation levels as a whole increased by approximately 80% in 2023. Youth participation had a 100% increase. 



The total number of Registered Programs that were offered in 2023 increased over 2022.




Number of Registered Programs Offered


Camps are offered during March Break and for 8 weeks in the summer. Camps are open to children between the ages of 4 and 12.

Staffing was very difficult in 2023. Applications for Camp Leader positions were low and all positions were not able to be filled. As leader-to-camper ratios needed to be maintained, staff lowered the number of spaces available at camp prior to the registration process. When the spaces were made available to the public for registration, they filled immediately. There was a waiting list for openings and staff filled spaces when cancelations occurred.

All options for utilizing Camp Leaders were exhausted. Part-season camp staff were hired in 2023 to increase the number of spaces available on certain weeks. Overall, there were not as many camper spaces available at camp in 2023 due to difficulties in hiring staff. The resulting decrease in participation/attendance levels is shown in the data below.

Participation/attendance levels are shown in the chart below. The data is shown as the number of campers registered each week. Campers attend each day; therefore, the participation/attendance level is the sum of all days in each week.

Hunting was divided by age into 3 groups. The intensity of the hunt created aggressiveness and disorder and it was determined that the "hunt" style of the event should be reconsidered.

Visitors to the event were asked to bring a food donation to the West Lincoln Community Care Food Bank.

Overall, the event was well received and the estimated attendance was 1250.

Earth Day

Earth Day is on April 22 each year. Recreation Services invites community groups, businesses, and individuals to participate in a Community Clean Up to celebrate Earth Day. Efforts are supporting by facilitating clean up locations, providing garbage bags and picking up collected garbage. Road-side and/or creek-side cleanup activities are

not recommended or facilitated by the Township. In 2022 there were 3 Earth Day events that registered with Recreation Services.

Farmers' Market

In 2023, the Farmers' Market continued with a full season from June 13, 2023 to October 3, 2023. An Easter market, two plant sale markets, a Canada Day market and a Winter market were also held.

The 2023 Farmers' Market was implemented by the Market Coordinator through funding received by the continuation of Regional Economic Development grant from the Ministry of Agriculture, Food and Rural Affairs. The funding ended in July 2023.

Vendor participation and attendance were both fair for the 2023 market season. There were some struggles with inclement weather which affected the events. Staff prepared some guidelines for decision making regarding weather to increase transparency and improve consistency.

The 2023 Market included special events such as a Teddy Bear Picnic in coordination with the Library and a Cooking Demonstration.

Music in the Park

In 2023 the Music in the Park concert series continued and increased from 4 to 6 events. Concerts were held on July 12, 19, 26, August 2, 9 and 16 from 7:00pm to dusk. The Kiwanis Club of West Lincoln collaborated to offer snacks at the events by donation. Staff secured sponsorships from local businesses to support the series. 1 of the 6 concerts was held indoors due to weather. The concerts were well attended and the estimated attendance over 6 concerts was 1000 to 1200. Staff received many comments and feedback from attendees about their enjoyment of the series.

Movies in the Park

In 2023, Movies in the Park events were continued and increased from 2 to 4 events. Movies were shown on July 14, 28, August 11 and 25 beginning at dusk. The Kiwanis Club of West Lincoln collaborated to offer snacks at the events by donation. 2 of the 4 movie nights were held indoors due to weather. Attendance over 4 movie nights was estimated at 350.

Harvest Routes

The Harvest Routes event returned in 2023 with both workshops and a Marketplace. Workshops were held on both Friday, September 29 and Saturday, September 30. On Friday, workshops were held at Caistor Community Centre and the West Lincoln Community Centre. On Saturday, workshops were held at the Wellandport Community Centre and the West Lincoln Community Centre. The Marketplace was held in the gymnasium at the Community Centre on September 30 from 10:00 a.m. to 4:00 p.m. A total attendance for workshops on both days was 430. 24 vendors were secured for participation at the Marketplace. It is estimated that the attendance of visitors to the Marketplace was approximately 250.

Parade

In 2023, the Parade Committee held a traditional style parade that began at the West Lincoln Community Centre and continued to Industrial Park Road. The West Lincoln Community Centre parking lot was used to stage entries and bands for the start of the parade.

Township staff played a roll in facilitating and executing the parade through the coordination of road closure permits and Niagara Regional Police services and Township Staff were on duty for the event to assist with parade entry coordination and road closures.




Arena Ice

The Arena/Ice season runs from September to April. This means that the season crosses two years and two budget periods. Covid-19 had effects on the data provided here for the month of January in the 2022. 2023 is a good representation of a full year of ice rentals. 2023 includes data from the 2022-2023 season and the 2023-2024 season.

The 2023-2024 season (September 2023 to April 2024) has just come to a close. The charts below includes January to March 2024 for reference. The months of September to December 2024 are upcoming as part of the 2024-2025 season.

There was an approximate 3% increase is ice user fees from the 2022-2023 season to the 2023-2024 season.


Gymnasium rental fees increased by approximately 3% from 2022 to 2023.

The charts below includes data from 2022 to 2024. It is important to note that there was no revenue from January to April in 2022 due to Covid-19 effects and recovery. The data shown for 2024 only includes revenue for the first three months of the year.

Although there was a dramatic increase in rentals from 2022 to 2023, the same increase is not expected in 2024 as gymnasium availability is becoming very limited.

Community Rooms

The Community Rooms are also very popular through the facility rental process. There are three rooms that can be rented as single, double or full (3). A kitchenette is also available for rental as part of Community Room 1. The rooms have been rented for many purposes. We often have rentals for children's birthday parties, meetings and family gatherings as well as regular rentals such as Port Cares/EarlyON programs, dance classes, and home school classes.


The Community Rooms are also used for Township drop-in programs like Older Adult Social, registered Township programs like yoga and partnership programs like the Niagara Region's Healthy Safe and Strong program.

The Community Rooms are critical to the Summer Camp program as they provide a space for crafts, activities and lunches. This means that the Community Rooms are not available for private rentals during the months of July and August each year.

The revenue reported here is from private rentals of the community rooms. Community Room rental fees increased by approximately 3% from 2022 to 2023.

SCHEDULE G Advertising/Vending Revenue

In August of 2019, the Township entered into an advertising agreement with Nustadia Media. The agreement has been renewed annually for the administration of the arena board advertising with \$16,000 revenue guaranteed per year. In 2022, \$16,000 was collected through this advertising agreement. In 2023, the same amount, \$16,000 was collected through the agreement.

The Township also has an agreement with Vendomatic for the administration and operation of vending machines in the West Lincoln Community Centre. The project guarantees the Township 15% of all vending machine sales.





SCHEDULE I Community Connections

Throughout the year, Staff explore opportunities to develop connections in the community that will create mutually beneficial outcomes and increase capacity and enhance services. These connections vary greatly, but each one assists in the improvement of programs, events or services.

Below is a list of community connections that were developed or continued during 2023.

Kiwanis Sponsored Youth Drop-in Programs

Drop-in programs are unstructured, physical activities that are open to all levels and abilities. Drop-in for gym fun with friends facilitated by Recreation Staff. Youth drop-in on Thursdays is a sponsored program by the *Kiwanis Club of West Lincoln*.

- Thursdays 4:30 p.m.- 6:00 p.m. 9-12 yrs
- Thursdays 6:00 p.m.- 7:30 p.m. 13-17 yrs

The Kiwanis Club of West Lincoln supported these programs throughout all of 2023 by paying the drop-in fees for all attendees, thereby making the programs free to participants.

Niagara Region Healthy, Safe and Strong Program

The Township of West Lincoln continued its partnership with the *Niagara Region* to offer a free community-based group exercise program that helps seniors improve balance, strength and reduce the chance of falls. This program is administered by the Niagara Region and is held at the West Lincoln Community Centre. Facility rental fees are not charged to the Niagara Region for the use of community rooms or for storage of equipment.

Sportball Niagara

The Township of West Lincoln continued its partnership with **Sportball Niagara** in 2023 to offer non-competitive sports instruction for children 16 months to 10 years. The programs were run in the gymnasium at the Community Centre for 3 sessions in 2023. The total number of participants in the programs in 2023 was 72 and the Township received \$1066.00 as a percentage of registration fees collected by Sportball Niagara.

Port Cares EarlyON Child and Family Centre

EarlyON is a Family Centre for parents and children to learn, play and grow. The EarlyON Centre offers free programs for parents/caregivers and children from birth to 6 years old. In 2023, the Township continued a facility rental agreement with Port Cares EarlyON for the rental of community room and gymnasium space at the Community Centre. EarlyON has also been provided with storage space for their program supplies as well as access to the kitchenette for programming staff.

Family Day Event Connections

At the 2023 Family Day event, the following community connections were made:

• Fire fighters' community breakfast hosted by West Lincoln Fire Services

- SuperSkills Hockey in partnership with *West Niagara Minor Hockey Association*
- Skipping demonstrations in partnership with *Lincoln Leapers*
- Sledge Hockey Match in partnership with *Parasport Niagara* and (vs.) WL Fire fighters
- Crime Stoppers Niagara information table
- Welland Jackfish mascot community outreach

March Break Camp

- West Lincoln Public Library Smithville Branch In 2023, the Township's March Break camp connected with the Smithville Branch of the Library to have a library visit as part of the camp programming plan.
- **Niagara Region** Subsidy Program The Township continued its connection with the Niagara Region to administer their subsidy program for March Break Camp participants who qualify.

Easter Event

In 2023, staff connected with *West Lincoln Community Care Food Bank* by collecting food bank items at the Easter Egg Hunt.

Earth Day Event

The Township of West Lincoln invites *local businesses, schools, youth groups, facility users and residents* to participate in a Community Clean Up event to celebrate Earth Day around April 22 each year. The Township supports efforts by facilitating clean up locations, providing garbage bags and picking up and disposing of collected garbage.

Hanging Basket Sponsorship Program

In 2023, Recreation Services continued with the Hanging Basket Sponsorship Program, where connections are made with *local businesses, community groups and individuals*. Businesses have an opportunity to show community support and Recreation Services develops a relationship with the business community.

Summer Camp

- West Lincoln Public Library Smithville Branch In 2023, the Township's Summer Camp Program partnered with the library to host a life-sized inflatable Planetarium on the arena floor.
- **Niagara Region** Subsidy Program The Township continued its connection with the Niagara Region in 2023 to administer their subsidy program for Summer Camp participants who qualify.

West Lincoln Farmers' Market

• West Lincoln Public Library – Smithville Branch – The library hosted a Teddy Bear Picnic in connection with the Farmers' Market in 2023. The picnic was intended to be outdoors, however, with poor weather in the forecast the Market Coordinator and the library collaborated to move the event indoors.

- **The Smithville Garden Club** joined with the Farmers' Market in 2023 to host two Plant Sale Markets in May.
- Staff invited the Farmers' Market for inclusion at the Canada Day event in 2023.

<u>Age Friendly Advisory Committee – Free Community Event</u>

The Township of *West Lincoln's Age Friendly Advisory Committee* hosts free events typically in the Spring and Fall aimed at arming the community with knowledge and tips to protect themselves and live safe and healthy lifestyles (particularly older adults).

- Events are hosted at the Community Centre and coordinated through the facility rental process with Recreation Services
- Events include guest speakers from West Lincoln Fire & Emergency Services, Niagara Regional Police Services, Merritt Funeral Home, West Lincoln Public Library, Canadian Anti-Fraud Centre

Movies in the Park

In 2023, staff continued the partnership with the *Kiwanis Club of West Lincoln* for the four Movies in the Park events. The partnership included Kiwanis providing snacks by donation for movie-goers which added value to the event and provided Kiwanis with community exposure.

Music in the Park

In 2023, staff continued the partnership with the *Kiwanis Club of West Lincoln* for six Music in the Park events. The partnership included Kiwanis providing snacks, by donation, for movie-goers which added value to the event and provided Kiwanis with community exposure.

Canada Day

In 2023, staff collaborated with the *West Lincoln Library* to offer activities as part of the Canada Day event. A collaboration with the *West Lincoln Youth Soccer Club* was also arranged to add Canada Day tattoos and stickers to the days activities.

Harvest Routes

As part of the 2023 Harvest Routes event, staff connected with *artists and makers* to create the Marketplace which supported their talents and provided an opportunity for sales. Vendors at the Harvest Routes Marketplace do not pay vendors fees. Staff also connect with *West Lincoln Community Care Food Bank* to coordinate the collection of food bank items in exchange for participation in a workshop that is taught by a volunteer local artist. These connections add value to the event and support the local arts and culture community.

West Lincoln Shines Community Tree Lighting

In 2023, the *Kiwanis Club of West Lincoln* planned and presented the annual community tree lighting event in partnership with the Township. The Township provides the lights on the tree and staff support each year. This event also included many other community connections as coordinated by Kiwanis. The following is a list of community connections made as part of the tree lighting event.

West Lincoln Santa Claus Parade

In 2023, the West Lincoln Santa Claus Parade Committee, a committee of council, met regularly throughout the year to coordinate the annual Santa Claus Parade. A staff liaison and a Council liaison were part of the Committee. Staff and Committee members managed all components of the event to present it to the community. The Committee partners with many different *organizations and businesses* to successfully present this community event. These connections foster community involvement and pride.

- Staff administered a cost sharing agreement with *Niagara Regional Police* Services (50/50) for the provision of policing and road safety at the event.
- Staff connected with the *Niagara Region* for the coordination of the road closure.
- Committee members made many connections with local businesses through their sponsorship campaign.
- Committee members also made connections with *local clubs, associations, and schools* as they recruited participants for the event.

Goosechase- Free Community Challenges (Past)

Niagara Economic Development provided the region-wide availability of GooseChase, a digital scavenger hunt platform. GooseChase allowed municipalities, chambers, BIA's, DMO's and other business-supporting organizations to create games and missions with the goal to attract customers in new, creative and safe ways.
