SUBJECT: Heavy Truck Restrictions on Young St, South Grimsby Road 8,

and South Chippawa Road

OVERVIEW:

 Following the past winter season, significant pavement failures and structural deterioration have occurred along roads throughout the Township, primarily along Young Street, South Grimsby Road 8, and South Chippawa Road, resulting in accelerated road damage from heavy truck traffic.

- Through inquiries from the public, Council members, and after completing a review, administration have identified the need to mitigate further deterioration and protect these corridors from premature failure through restrictions on heavy truck use.
- It is recommended that heavy truck access be prohibited on the identified sections of roadway, with exemptions only as permitted under the Highway Traffic Act (e.g., local deliveries, emergency services, farm machinery), through an amendment to Schedule "S" of the Township's Traffic and Parking By-law 89-2000.
- Implementing these restrictions will reduce further damage to the road base and surface and allow staff to better prioritize and plan for long-term rehabilitation efforts.

RECOMMENDATION:

- 1. That, Recommendation Report O-17-2025, "Heavy Truck Restrictions on Young St, South Grimsby Rd 8, and South Chippawa Road", dated September 8, 2025, be received; and,
- 2. That, a draft bylaw such as the one attached as Schedule "A" to amend Schedule "S" of By-Law 89-2000 to include heavy truck restrictions on Young Street (between Regional Road 14 and Regional Road 12), South Grimsby Road 8 (between Regional Road 20 and Twenty Road), and South Chippawa Road (between Regional Road 63 and Regional Road 2), be approved.

ALIGNMENT TO STRATEGIC PLAN:

Theme # 1

• BUILD - A safe and connected, caring, and active community

BACKGROUND:

The Township of West Lincoln maintains a road network that serves a mix of residential, agricultural, and commercial/industrial users. As part of this network, certain roadway segments are designated with heavy truck restrictions under Schedule "S" of the Township's Traffic and Parking By-law 89-2000. These restrictions are generally applied where road conditions, roadway geometry, or community impacts make it unsuitable for accommodating large volumes of heavy truck traffic.

The intent of these restrictions is to:

- Preserve the structural integrity and extend the service life of roadway assets that were not designed to withstand repeated heavy truck loading.
- Enhance roadway safety by reducing conflicts between heavy trucks, passenger vehicles, cyclists, and pedestrians.
- Direct heavy truck traffic toward arterial and regional roadways that are built to accommodate higher load demands.

Over time, these truck restriction designations have proven effective in protecting vulnerable road segments while ensuring that local deliveries and farm equipment can continue to access properties under exemptions permitted by the Highway Traffic Act. The proposed restrictions identified in this report are consistent with this established practice and reflect the Township's ongoing approach to managing heavy truck activity in appropriate areas of the network.

CURRENT SITUATION:

During the 2025 early Spring season, Township administration observed accelerated deterioration on several roadway segments within the Township's network. In particular, Young Street, South Grimsby Rd 8, and South Chippawa Road experienced extensive pavement failures and rutting. These conditions have been further compounded by ongoing heavy truck usage, which has significantly reduced the service life of these roads and created additional pavement repairs.

In response, Township administration has concerns regarding the long-term viability of these corridors if truck traffic is permitted to continue without restrictions. The combination of repeated freeze-thaw cycles, structural integrity on these rural roadways, and the use by

heavy trucks has resulted in conditions that require immediate intervention to prevent further costly damage.

The Township's Traffic and Parking By-law 89-2000 provides authority to regulate and restrict truck traffic on designated roadways, through Schedule "S". A review of the affected road segments indicates that restricting heavy truck access is an appropriate and necessary measure to preserve the integrity of the infrastructure until such time that full reconstruction can be considered through the Township's capital planning process.

Administration is recommending that Schedule "S" of By-Law 89-2000 be amended to include heavy truck restrictions on these three road sections:

- Young Street Between Regional Road 14 (Thirty Rd) and Regional Road 12 (Grimsby Rd)
- South Grimsby Road 8 Between Regional Road 20 and Twenty Road
- South Chippawa Road Between Regional Road 63 (Canborough Rd) and Regional Road 2 (Caistorville Rd)

FINANCIAL IMPLICATIONS:

The approximate total pavement repair costs on these sections of roads were in the order of \$50,000 to \$60,000.

Signage restricting heavy truck will help mitigate any future repair costs. Heavy truck restriction signage will need to be installed on each road segment at an approximate cost of \$500.

There are sufficient funds in the 2025 approved Operating Budget to cover this cost.

INTER-DEPARTMENTAL COMMENTS:

This report has been reviewed by the CAO, the Director of Corporate Services/CFO, and the Clerk's office.

CONCLUSION:

The deterioration of Young Street, South Grimsby Rd 8, and South Chippawa Road has highlighted the vulnerability of certain rural roadways within the Township when subjected to sustained heavy truck traffic. Implementing truck restrictions on these sections, consistent with the Township's existing practice and authority under the Traffic and Parking By-law 89-2000, represents a proactive step to mitigate pavement deterioration, roadway failures, and additional maintenance / repair costs. By updating Schedule "S" to

include these road segments, Council will ensure that truck traffic is directed to appropriate corridors while maintaining essential access for local needs.

NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF WEST LINCOLN ENACTS AS FOLLOWS:



OVERVIEW:

- A report was presented to the Operations Committee on May 12, 2025, recommending that Council approve the proposal to utilize the Township's share of the Region's Vision Zero Revenue program (totaling \$56,954.00) to develop and issue a Request for Proposal (RFP) to retain a qualified consultant to create a comprehensive Road Safety Action Plan.
- A Request for Proposal (RFP) for this assignment was posted in July 2025 with a closing date of July 31, 2025. Four proposals were received and reviewed.
- As per the Township's Procurement Policy, LEA Consulting Ltd., (LEA) had the
 overall highest score and Administration has awarded this assignment to LEA
 through delegated authority.
- LEA Consulting Ltd., will be available to present their workplan to the Operations Committee on Tuesday October 14th, 2025.
- The purpose of the October 14th presentation will be to inform Committee/Council Members on the work plan and the deliverables associated with this Road Safety Action Plan.
- In order for a successful project delivery, it is important that Council Members are well informed of the work plan and deliverables prior to any public engagement, commencement of data collection, commencement of any pilot projects, and consultation with the community.

Theme # 1

BUILD – a safe, connected, caring and active community

Respecting Our Roots, Realizing Our Future

BACKGROUND:

Niagara Region's Vision Zero Program aims to eliminate traffic fatalities and serious injuries on Regional Roads through measures such as Automated Speed Enforcement (ASE) and Red Light Camera (RLC). Any net revenues from these measures are split 50/50 between the Region and the Local Area Municipalities, including the Township of West Lincoln. The revenue received by the Township is to be reinvested into road safety related programs and educational initiatives. The Township's share of the Vision Zero program revenues for 2024 was \$56,954.00.

A report was presented to the Operations Committee on May 12, 2025, recommending that Council approve the proposal to utilize the Township's share, totalling \$56,954.00 to develop and issue a Request for Proposal (RFP) to retain a qualified consultant to create a comprehensive Road Safety Action Plan.

CURRENT SITUATION:

An RFP for this assignment was posted in July 2025 with a closing date of July 31, 2025. Four proposals were received and reviewed. The proposal submissions were evaluated based on a value for money assessment with 80% towards technical criteria (Expertise; Experience; Methodology/Work Plan; Public Engagement; and Timeline) and with 20% towards costs. The proposal submissions and a summary of Administration's evaluation is summarized below:

As per the Township's Tendering and Purchasing Policy, LEA Consulting Ltd., (LEA) had the overall highest score and Administration has awarded this assignment to LEA through delegated authority. LEA has the necessary expertise and experience to complete this project successfully.

The RFP Document was structured in a way to award the assignment based on the existing budget amount (\$56,954.00) in order to commence the Road Safety Action Plan now (in 2025) with a provisional price to continue and finalize the Road Safety Action Plan in 2026 when additional revenue is received from Niagara Region from the Vision Zero Program.

A project / kick off meeting was held on August 29th, 2025, between Administration and LEA Consulting Ltd., to commence the workplan as outlined in the RFP document and consultant's proposed workplan.

LEA Consulting Ltd., will be available to present their workplan to the Operations Committee on Tuesday October 14th, 2025. The purpose of this presentation will be to inform Committee/Council Members on the work plan and the deliverables associated with the Study / Action Plan. For a successful project delivery, it is important that Council Members are well informed of the work plan and deliverables prior to any public engagement, commencement of data collection, commencement of any pilot projects, and consultation with the community.

FINANCIAL IMPLICATIONS:

At the May 12, 2025, meeting, Operations Committee approved Budget Amendment (BA2025-05) in the amount of \$56,954.00 for this project, with funding from the Vision Zero Program revenues.

This assignment has been awarded to LEA Consulting Ltd., based on the existing budget amount of \$56,954.00, in order to commence the Road Safety Action Plan now (in 2025). The remaining costs/fees for this assignment will be awarded when additional revenue is received from Niagara Region from the Vision Zero Program. It is expected that this additional revenue will be received in May or June of 2026.

INTER-DEPARTMENTAL COMMENTS:

This report has been reviewed by the CAO, the Director of Corporate Services/CFO, and the Clerk's office.

CONCLUSION:

The purpose of this Report is to provide an update to Operations Committee/Council members on the Road Safety Action Plan. This work has been awarded to LEA Consulting Ltd., and the project has commenced with a project/kick off meeting on August 29th, 2025. LEA Consulting Ltd., will be available to present their workplan and the deliverables of this Study to the Operations Committee on Tuesday October 14th, 2025.
